# Rules - call for presentations

# Article 1 - Objective of the call for presentations

This year, the Forum InCyber (FIC) will devote a space to presentations and demonstrations of ethical hacking. The aim of these presentations is to encourage research into vulnerabilities and ethical hacking. The purpose of this call for presentations is to enable the event organizer to select the presentations that will be included in the program for this area.

# Article 2 - Content of presentations

Presentations must be non-commercial and deal with the cybersecurity of software or hardware components. In particular, they may cover the following methods and techniques: Reverse engineering ; Vulnerability research ; Malware analysis; Cryptographic attacks; Physical attacks; Field observation techniques (blue team, operational staff...) ; ...

# Article 3 - Legality of content

Presentations must not contain any content likely to violate the legal provisions and rules in force on French or Canadian territory in terms of intellectual property and information systems security. Candidates assume full responsibility for the content presented.

# Article 4 - Language of presentations

Presentations will be given in French or English.

# Article 5 - Submission of proposals

Presentation proposals should be sent to the organizer by PDF form at programme@forum-fic.com. The call is open between July 3, 2023 and August 15, 2023.

#### Article 6 - Content of responses to the call for proposals

Responses to the call for proposals must be submitted using the PDF form and must include the following information:

Title Description (500 to 1000 words) covering the objective and issues addressed Language of presentation (French or English) Name of contributor(s) Email address of contributor(s) Biographical details of contributor(s) (publications, position, etc.).

Answers may be submitted in English or French. Anonymous contributions will not be considered.

# Article 7 - Evaluation of entries

The FIC organization will evaluate each submission between August 15, 2023 and August 30, 2023.

The selection criteria will be as follows: Innovative nature of the presentation; Operational interest.

The results will be communicated to applicants between September 11 and 15, 2023.

#### **Article 8 - Application conditions**

This call for proposals is open to all. Demonstrations must be presented individually by the researcher(s) or expert(s), and not on behalf of their company/organization. They must not contain any commercial content.

Demonstrations become chargeable if they are made for commercial purposes. Rates are as follows: 15 minutes: \$1,500 CAD 30 minutes: \$2,500 CAD 45 minutes: \$4,500 CAD

#### Article 9 - Intellectual property

The intellectual property of the contents presented is and remains the exclusive property of their authors.

#### Article 10 - Image rights

Candidates accept that their presentations will take place publicly during the event and will be rebroadcast live and replayed on the FIC and inCyber channels. They assign their corresponding image rights to the event organizer.

#### Article 11 - Financial conditions

Presentations made within the framework of this call for projects do not give rise to any remuneration on the part of the event organizer. They take place entirely free of charge and are not subject to any condition of partnership with the event.
